




The Bureau of Agriculture and Fisheries Standards of the Department of Agriculture (DA-BAFS) issued this Certificate of Registration (COR) to this producer pursuant to DA Department Circular No. 04, Series of 2020, Guidelines on the Registration of Organic Soil Amendments (OSA) Producers and Products, with compliance to the Philippine National Standard (PNS) for Code of Practice for the Production of Organic Soil Amendments and PNS for Organic Soil Amendments subject to the terms and conditions below.

TERMS AND CONDITIONS

1. The DA-BAFS shall suspend this COR based on any of the following grounds:
 - a) non-submission of new organic certificate within one (1) month after its expiration in accordance with the Section 4 of Article XII of the DA Department Circular No. 04, Series of 2020; and
 - b) non-conformance to current version of PNS relevant to organic agriculture and other regulatory requirements per post-market surveillance report.
2. The DA-BAFS shall revoke this COR based on any of the following grounds:
 - a) revocation of organic certificate by an officially accredited organic certifying body (OCB); and
 - b) failure of the registered producer to implement corrective actions within the suspension period.
3. As required by RA 10068, PNS/BAFS 183:2016 and DA DC No. 04 s. 2020, the herein registered OSA producer shall indicate the following information on the label of its OSA product(s):
 - a) name, logo or seal of the DA-BAFS' officially accredited OCB;
 - b) "organic" mark together with the OCB's official accreditation number provided by the DA-BAFS' officially accredited OCB;
 - c) product registration number and validity period provided by DA-BAFS;
 - d) for bottles and cartons: trade name; descriptive statement; art work; Registered by the Bureau of Agriculture and Fisheries Standards pursuant to RA 10068; net content; storage and disposal; prohibition; warranty; direction for use; warning or precautions; product information; raw materials used; nutrient content - Nitrogen (N)%, Phosphorous (P_2O_5)% and Potassium (K_2O)%; product description and type; claims; compatibility with bio-pesticides; lot or batch number; expiry date; name of manufacturer or distributor, address and contact number; and
 - e) for bags and sachets: brand name; art work; nutrient content - Nitrogen (N)%, Phosphorous (P_2O_5)% and Potassium (K_2O)%; CN ratio; moisture content; trace and secondary nutrients (ppm for each nutrient, if any); claims; compatibility with bio-pesticides; name and address of local manufacturer or importer or distributor; direction for use; warning or precautions; batch number; lot number or code; date of manufacture or importation (if applicable).
4. The herein registered OSA producer shall allow the DA-BAFS assigned team to conduct and enter in the herein registered producer's office, production and storage areas during monitoring activities. The DA-BAFS monitoring activities will be conducted at least once a year or within the validity of this COR.
5. The herein registered OSA producer must apply for renewal of its COR within three (3) months prior to its expiration.
6. The herein registered OSA producer shall return this original COR to DA-BAFS after its expiration or once it has been renewed, amended or revoked.
